KTA Announces Provisional Winners of the 17th Wave Only one valid bid for SSO Moravamont

PRISTINA – The Kosovo Trust Agency announced the provisional winners of the 17th Wave of Privatisation at today's 17th Bid Opening Ceremony.

Highlights

- A total of 26 NewCos were available for purchase.
- 25 NewCos were available via "Regular Spin-off."
- 1 NewCo – Moravamont – was available via "Special Spin-off."

109 bids were received for the Regular Spin-off NewCos. The total value of the highest bids, in total, was €7,173,293.

2 bids were received for Moravamont; however, one of the bids, which was placed in Mitrovica, was not a valid bid and was rejected.

The sole valid bid for Moravamont was for €246,000, and also included an investment commitment of €1,400,000 and an employment commitment of 135.

There was discussion regarding the provisional winner for one NewCo, Universiteti I Punetoreve Ferizaj. The dispute centered on a bid, which had a numeric bid figure that was lower than the written bid figure. KTA officials, following consultation with KTA legal officers, elected to accept the higher, written bid figure. This decision must be approved by the KTA Board.

The results, and winners, given below are provisional. The Kosovo Trust Agency is now working to finalize all sales, contingent upon background checks and the completion of payments by the provisional winning bidders, and finalization of all sales contracts.
